Extract from Club Rules Relating to Membership

Qualification for Membership

Any person aged 18 years and above shall be eligible to apply for membership of the Club.

Cadet Members

Young persons under 18 years of age may apply for Cadet Membership.

Young Adult Members

Any person aged 18 or over but not over 25 shall be eligible for young adult membership. (Proof of age is necessary)

Joint Members

Which expression shall include married couples or co-dwelling partners

Family Members

Applies to members' children under 18 years

Proposal of candidates

Every candidate applying for membership of the club (except in the case of Honorary, Temporary and those marked * below) must be proposed and seconded by **two Full members** of the Club, **each of at least one years standing**.

The Proposer and Secunder are requested to give a short note of their knowledge and their recommendation of the Candidate on the reverse of this form, and sign and print their name on the front page of the form.

*If the Applicant is a bona fide Member of a Yacht or Boat Club affiliated to the RYA then a letter of recommendation signed by or on behalf of that Club shall suffice instead of the Proposer and Secunder.

*Any Brixham Berth Holder shall be eligible to apply for Membership upon the recommendation of the Executive Committee.

Admission of Members

The name, address, contact details and occupation of any Candidate for election as a Member of the Club and the name of Proposer and Secunder shall be stated on the proposal form and returned to the Honorary Secretary.

The Secretary shall post a list of applicants for Membership on the Club Notice Board for at least seven consecutive days before the meeting of the Executive Committee at which the proposal is heard. Candidates shall be elected on a simple majority of the Executive Committee present and voting.

The Executive Committee shall be under no obligation to notify unsuccessful candidates of the reasons (if any) why their application has been rejected.
